

#### 3 Barriers of Multiculturalism in Japan

# 1. Language

Ex)kanji, pseudonym, unit, expression

# 2. System

Ex) name, nationality clause, voting rights

### 3. Belief

Ex) discrimination against residents, Residency management system

# Language, System, Belief


#### Special examination in Osaka

- English, Math, Japanese essay


#### Returnee examination in Osaka


