## **I** Introduction

#### • Background

Some Japanese laws have not been revised for years even though the social needs have greatly changed. In Japan, since the Meiji era, Penal Code Article(212-216) has banned abortion. However, if certain conditions are met, abortion is permitted under the Maternal Protection Act. But consent from the spouse is required. And currently, only 11 countries require consent from spouse to have an abortion.


#### • Purpose

In June 2022, the U.S. Supreme Court overturned the 1973 Roe v. Wade decision. As a result, in each U.S. state imposing its own state laws on abortion. While in office, Trump nominated three conservative judges to the Supreme Court. When Trump took office in 2016, the balance on the Supreme Court was equal with four liberals and four conservatives. However, by the time he retired, there were six conservatives and three liberals, consolidating the control of conservatives.



This case is controversial, but if the conservative Clinton had become president instead of Trump, this situation would not have happened. From this, we can see that the three powers of politics, administration, and judiciary need people who can think with diversity, because the ideas of those who decide on systems have a great impact on society.

## **V** Successful case in France

A major turning point for France was "Parité Law,". Parite originally meant "equivalent". The law requires political parties to field an equal number of male and female candidates. The parite law is said to have made France a gender-advanced country. Since the enactment of the Parite Act, women have played an active role in politics. The proportion of women serving as Diet members exceeds 40%, and the proportion of men and women serving as ministers is almost equal.

## **VI** Conclusion

From the comparison with abortion laws in Laos and the U.S., it seems that a diverse way of thinking is important in the three powers of Congress, judiciary and administration. As in France, the revision of laws and the establishment of new systems can greatly improve gender inequality. Japan currently has a very large gender gap in the political field. In order to create a system that meets the needs of society, Japan will also need to take the current situation of the gender gap seriously and first aim for gender equality in the three powers of justice, administration, and the Diet.
