


# “Furusato NISA” for Local Area Development



## Introduction

### What is “Furusato Nozei”?



### “Furusato Nozei” system is becoming popular



- Total Amount of the donation is rapidly growing.
- In the past 5 years, the amount has grown by more than 2.5 times.

### Causes

- It seems to offer **only benefits** to users

**However, is that true?**

## Problems with “Furusato Nozei”

### Principles of Tax “Benefits Principle”

→Taxpayers should pay for public services **in proportion to the benefits they receive**.

### But...


- Donating to another city reduces the own city's tax revenue.  
→It makes the city's public services such as education, and fire service
- This disadvantage affects **not only those who receive return gifts but also those who do not receive the gifts**
- Urban areas face shortage of tax revenue  
→Urban areas have larger population and that means more people use the system than other areas. It causes shortage of the revenue.

## Underlying Issue

“Furusato Nozei” System is for **the local development**.

### But...

#### Share of Received Funds



- Only about half of the funds are used for public services
- This system creates competition over a limited pie of the local tax revenue, so **the pie itself is not getting bigger**.

➡ **How do we achieve long-term and overall growth of local tax revenue?**

## Proposal

### Solution : **Investment**

- Development of Local Area  
⇔ **Development of Local Companies**

#### Aim of New System

- Investment in local companies and their growth
- Local Job Creation
- Growth in Corporate Tax Revenue**  
(Growth in Population and Resident Tax Revenue)

- Resolve the Problem of “Benefits Principle”**
  - Local Areas would Truly Develop**

“Furusato Nozei” × “NISA”


•Return Gifts System



•Tax Free Investment System

→Normally, there is a tax on profits we gained with investment. But with this, we can invest tax-free

⇔ **People can receive return gifts by investing in local companies**



## Evaluation

### Merits

- Consumption from local businesses would increase
- Both large companies and small and medium company can benefit
- Job Creation → Growth in **Population / Local Government's Revenue**
- The shortage of tax revenue in urban areas would be resolved

- How to choose up “Furusato Company”
- If government runs a deficit
- What areas are urban and not

## Conclusion

By stopping “Furusato Nozei” but keeping its good points and combining it with “NISA”, investment in local companies would be promoted.
